Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Duncan moved to approve the agenda as presented. CM Wilhelm voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the January 7, 2026 regular council meeting. CM Wilhelm moved to approve the minutes as presented. CM Lambert voiced the second and the motion carried unanimously.

POLICE ITEMS: PC Andrews reported: that the majority of her time during the reporting period was dedicated to traffic enforcement activities.

MAINTENANCE ITEMS: TS Dailey reported: ATS Jackson successfully passed his lagoon operator examination. The Maintenance Department has been addressing cleanup efforts following recent wind damage. A power installation is scheduled to take place at the Pine Bluffs Sinclair fuel station site. Utility locates for WYDOT have been completed. The street sweeper has been repaired and is operational. Verizon will be installing fiber internet cable to its tower.

LVFD ITEMS: CM Lambert reported: The annual coyote hunt is scheduled for the weekend of February 6, 2026. The competition will begin at the fire hall at 6:00 p.m., and several sponsors have been secured for the event.

ADMINISTRATIVE ITEMS: C/T Reyes reported: He has registered to attend the Wyoming Association of Municipalities (WAM) Winter Conference, scheduled for February 11–13, 2026, at Little America in Cheyenne, Wyoming. Following discussion, CM Jerome moved to approve CM Duncan's attendance at the WAM Winter Conference. CM Wilhelm seconded the motion, and the motion carried unanimously. Clerk/Treasurer Reyes also reported that IRS Form 1095-B (Proof of Insurance) has been submitted for all full-time employees.

RESOLUTIONS: Resolution #146, **A Resolution Appointing a Representative for the Town of Lingle to the Wyoming Municipal Power Agency (WMPA) Board of Directors for the 2026–2029 Three-Year Term.** Following the reading of Resolution #146, CM Wilhelm moved to approve the appointment of TS Dailey to the WMPA Board of Directors for the term of February 2026 through February 2029. CM Duncan seconded the motion, and the motion carried unanimously.

COUNCIL ITEMS: CM Wilhelm reported that a town resident suggested xeriscaping the cemetery as a potential cost-saving measure. No action was taken.
