The Regular Meeting of the Lingle Town Council convened at 6:00 PM January 7, 2026 with Mayor Foster leading the Pledge of Allegiance. Upon roll call, the following were present, constituting a quorum:

Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Wilhelm moved to approve the agenda as presented. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the December 3, 2025 regular council meeting. CM Wilhelm moved to approve the minutes as presented. CM Lambert voiced the second and the motion carried unanimously.

BILLS: CM Lambert noted a discrepancy of \$6.85 in the presented bill listing. Following discussion, CM Lambert moved to approve payment of the town bills in the amount of \$125,093.56. CM Wilhelm voiced the second and the motion carried unanimously.

POLICE ITEMS: PC Andrews reported: Her time during the reporting period has primarily been directed toward traffic enforcement and dog-related matters.

LEGAL ITEMS: TA Barnes reported: She attended the Chugwater Wind Project meeting in Chugwater on December 29, 2025. The Town of Lingle's request for impact funding was approved. A permit to begin construction is expected to be issued within 45 days. Annual impact reporting will be required in order for the town to receive funding.

MAINTENANCE ITEMS: Mayor Foster reported: The Maintenance Department has been working on various electrical projects throughout town, repairing the street sweeper, and completing work at the landfill in preparation for construction of a storage building.

LVFD ITEMS: FC Bangerter reported: Eight ambulance calls and three fire calls for the previous month. Fire service impact assistance related to the Chugwater Wind Project was approved. The annual Coyote Hunt fundraiser is scheduled for February 6, 2026. Chief Bangerter also reported that he will be working with Airlink to develop an air response plan.

ADMINISTRATIVE ITEMS: C/T Reyes reported: He attended the Chugwater Wind Project meeting on December 29, 2025. Requested impact funds in the amount of \$52,075.00 were approved for the Town of Lingle.

NEW BUSINESS: CM Wilhelm moved to approve the renewal of the contract with 120Water in the amount of \$4,400.00. CM Jerome voiced the second and the motion carried unanimously.
