Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Wilhelm moved to approve the agenda with the addition of a Fire Prevention Week Proclamation to New Business. CM Jerome voiced the second and the motion carried unanimously as amended. Mayor Foster called for approval of the minutes of the September 24, 2025 regular council meeting. CM Lambert moved to approve the minutes as presented. CM Jerome voiced the second and the motion carried unanimously.

BILLS: CM Lambert moved to approve payment of the town bills in the amount of \$114,184.59. CM Wilhelm voiced the second and the motion carried unanimously.

PUBLIC COMMENT: Resident George Siglin discussed weeds in the Town of Lingle and offered to help solve the issue in the park and cemetery.

POLICE ITEMS: PC Andrews reported: She had juvenile court; CM Lambert will be supervising a juvenile performing community service; Three new traffic trailers have been put into service.

LEGAL ITEMS: TA Barnes reported: An impact meeting for the Chugwater Wind Energy Project will take place October 14, 2025 in the Goshen County Commissioners Room.

MAINTENANCE ITEMS: TS Dailey reported: An arborist examined the trees in the cemetery. The spruce trees have a fungus and the cedar trees are infected with red borers. The cedars will need to be cut down and burned; The Tree Board discussed the installation of a sprinkler system at the cemetery.

LVFD ITEMS: CM Lambert reported: Thirteen ambulance calls and five fire calls last month; Fire Safety Day took place at the school; A haunted house will be provided to the public in conjunction with Halloween at the fire hall.

ADMINISTRATIVE ITEMS: C/T Reyes reported: The Wyoming Dept. of Audit reported that the town is compliant with the FY25 census requirements; All town facilities will be closed October 13, 2025 for Columbus Day.

NEW BUSINESS: CM Jerome moved to approve a Fire Safety Week proclamation. CM Wilhelm voiced the second and the motion carried unanimously. CM Wilhelm moved to approve the RFP for a steel building at the Transfer Station. CM Duncan voiced the second and the motion carried unanimously.

COUNCIL ITEMS: CM Lambert told the council that she assisted with the town self-audit and all was in order.

With no further business to conduct Mayor Foster adjourned the meeting at 6:32 PM.
