Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Wilhelm moved to approve the agenda as presented. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the November 19, 2025 regular council meeting. CM Lambert moved to approve the minutes as presented. CM Wilhelm voiced the second and the motion carried unanimously.

BILLS: CM Lambert moved to approve payment of the town bills in the amount of \$154,573.78. CM Wilhelm voiced the second and the motion carried unanimously.

POLICE ITEMS: PC Andrews reported: Her time has been directed at traffic; The police car will be going to Transwest Motors for repairs tomorrow.

LEGAL ITEMS: TA Barnes reported: The she attended the November Industry Siting meetings in Chugwater and meetings will reconvene in January 2026.

MAINTENANCE ITEMS: TS Dailey reported: He completed and submitted a tree survey to the State of Wyoming; WYDOT is performing a mapping survey in town.

LVFD ITEMS: FC Bangerter reported: Sixteen ambulance calls and one fire call last month; The heaters will be installed in the fire hall soon; The Giving Tree promotion is underway and donations are being accepted.

ADMINISTRATIVE ITEMS: C/T Reyes reported: He attended the Chugwater Wind Project Impact meeting November 21, 2025. The impact portion of the meeting was recessed and will reconvene in January 2026; The annual municipal water use report was submitted to the State Engineers Office.

NEW BUSINESS: CM Wilhelm moved to approve the town's annual membership to Go Goshen. CM Jerome voiced the second and the motion carried unanimously. Council members agreed to continue the Community Lighting Contest with the addition that local residents will vote for the winners of the contest. Voting will be open until December 29, 2025. Winners will receive a credit on their utility bills. First place will receive \$100 credit, Second place \$75 credit and third place \$50 credit. Mayor Foster requested to waive the December 17, 2025 meeting. CM Jerome moved to waive the December 17, 2025 meeting. CM Wilhelm voiced the second and the motion carried unanimously.
