The Regular Meeting of the Lingle Town Council convened at 6:00 PM April 8, 2026 with Mayor Foster leading the Pledge of Allegiance. Upon roll call, the following were present, constituting a quorum:

Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Wilhelm moved to approve the agenda as presented. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the March 18, 2026 regular council meeting. CM Wilhelm moved to approve the minutes as presented. CM Lambert voiced the second and the motion carried unanimously.

**BILLS:** Council Member Lambert moved to approve payment of the town's bills for the month of March 2026, totaling \$115,176.65. Council Member Wilhelm voiced the second and the motion carried unanimously.

**PUBLIC COMMENT:** Deb Grandy and Whitney Flores representing Wyoming Child and Family presented information to the council on the services they provide to Goshen County residents. They expressed thanks to the council and Town of Lingle for their past support and requested future monetary support in the amount of \$600.00. Resident Lindy Ellis asked if any events are planned for the Semiquincentennial celebration, C/T Reyes responded that the Army Band from Wheatland will be providing a free concert in the park in late June. Sarah Ingram of the Lingle Tree Board informed the council that trees purchased from the Lingle/Ft. Laramie Soil Conservation District will be planted in celebration of Arbor Day. Residents George Siglin, Brian Ingram and other residents attending the council meeting addressed the Stop sign installed at Freimuth and 7<sup>th</sup>. Following comments by residents and council members Mayor Foster stated that the sign will remain in place at this time.

**MAINTENANCE ITEMS:** TS Dailey reported: Water tests for Volatile Organic Compounds, Inorganic Contaminants and Synthetic Organic Compounds were not conducted from 2023 to 2025 and the situation is being corrected. The WMPA Board meeting will take place May 21<sup>st</sup> and a dinner is being offered to council members and town employees on May 20<sup>th</sup> in Guernsey, WY. TS Dailey presented an Arbor Day Proclamation signed by Mayor Foster proclaiming April 15, 2026 as Arbor Day. TS Dailey will be monitoring water levels and requests that residents be responsible when watering. June 1<sup>st</sup> thru the 5<sup>th</sup> is cleanup week for Lingle. The fitness equipment to be placed in the park has been ordered. The streets are being cleaned and a town cleaning schedule is being considered. The street corners on the highway will be widened and sloped by WYDOT to make them ADA compliant. Fire alarm issues have been resolved at the Community Center and the monitoring will be from Cheyenne. ATS Jackson will be attending the water conference April 21-24, 2026.

LVFD ITEMS: CM Lambert reported: During the past month, the department responded to five ambulance calls and one fire call. The annual Easter Egg Hunt was a success.

ADMINISTRATIVE ITEMS: C/T Reyes reported: The Municipal Electric Enterprises Annual Report has been submitted to the Wyoming Dept. of Revenue. The annual electrical report to the U.S. Dept. of Energy has been submitted. The application for municipal liability insurance to the Wyoming Local Liability Government Pool has been submitted for fiscal year 2027. Liquor license renewals have been distributed. The Town of Lingle Municipal election will take place May 5, 2026 from 7:00 AM to 9:00 PM in the Lingle Community Center. Absentee and mail in ballots will be available April 22, 2026 and due in the town office by May 4, 2026 by 4:00 PM. The candidates for Mayor are George Siglin and Shelly Duncan. The candidates for 2 council seats are Katherine Lynn Wilhelm, Brian Ingram, Bryan Kirk and Delwin Watson.

NEW BUSINESS: Following discussion, CM Duncan moved to approve support for the Hazardous Waste Cleanup Day in the amount of \$200.00. CM Wilhem voiced the second and the motion carried unanimously. The council voted by consensus to appoint ATS Jackson the town's voting delegate at the Wyoming Assoc. of Rural Water System Board meeting and appointed Emily Cottrell Pool Manager and Brandie Gibson Assistant Pool Manager for the 2026 Pool Season.

COUNCIL ITEMS: CM suggested a strategic planning session for the Town of Lingle that would include the town residents. She informed the council and all attending that a life skills fair for students will take place May 6, 2026. It is sponsored by realtors. CM Jerome announced his resignation from the council effective immediately. With no further business to come before the Council, Mayor Foster adjourned the meeting at 6:56 p.m.
