Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda with the addition of Lindy Ellis to "Public Comment." CM Wilhelm moved to approve the agenda as amended. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the June 4, 2025 regular council meeting. CM Wilhelm moved to approve the minutes as presented. CM Lambert voiced the second and the motion carried unanimously.

PUBLIC COMMENT: Resident Lindy Ellis reported that the flowers have been planted in the flower pots located throughout town. The All School Reunion will take place in Whipple Park June 28, 2025 10am to 4pm. Various activities will take place with a street dance taking place on 2nd Street next to the Corner Bar in the evening from 8pm to midnight.

MAINTENANCE ITEMS: ATS Jackson reported: Cleanup of the storm debris is complete; Electrical service upgrades have been done; The swimming pool is operational and basic maintenance to the town is ongoing.

POOL ITEMS: PM Cottrell reported: All pool staff are trained; PM Cottrell thanked TS Dailey and ATS Jackson for the hard work to get the swimming pool up and running; The swimming pool has received an overflow of Torrington residents; Swimming lessons will begin next week.

ADMINISTRATIVE ITEMS: C/T Reyes reported: He attended the WAM convention and updated the council on the "session's" he attended. The town was approached by a Lingle resident wanting to sponsor a musical event in Whipple Park. Plans are being made for a tentative date of August 12 with the assistance of the Main Street Program from Go Goshen; C/T Reyes informed the council that he has volunteered to serve on the Goshen County America 250 Committee.

ORDINANCES: CM Wilhelm moved to approve the third reading of Ordinance #375 AN ORDINANCE PROVIDING FOR THE ANNUAL APPROPRIATION FOR THE TOWN OF LINGLE FOR THE FISCAL YEAR JULY 1, 2025 TO JUNE 30, 2026. CM Jerome voiced the second and the motion carried unanimously.

NEW BUSINESS: CM Wilhelm moved to approve the liquor license renewals for The Corner Bar, Lira's Restaurant and Ty's Pitstop. CM Jerome voiced the second and the motion carried unanimously.
