POOL ITEMS: Mayor pro tem Wilhelm reported: The last day of seasonal operation of the Lingle Pool is scheduled for August 31, 2025; The Elks Club will be sponsoring a free swim night August 25, 2025; the pool will be closed July 31, 2025 for Goshen County Day; the pool has been very busy.

MAINTENANCE ITEMS: TS Dailey reported: The Pine Bluffs Sinclair building permit has been submitted and approved; The pool heater is repaired; Goshen County Cattle Women banners have been put up on Main Street; Street repair will take place by Lira's Restaurant; TS Dailey requested and the council approved by consensus to install stop signs at 7th Street and Freimuth Avenue and 9th Street and Sherman Avenue.

LVFD ITEMS: LVFD FC Bangerter reported: Everything is business as usual.

ADMINISTRATIVE ITEMS: C/T Reyes reported: All town facilities will be closed July 31, 2025 for Goshen County Day; MHP, CPA Firm has agreed to assist the town with the F-66 financial report to the state; Entertainment is scheduled to take place in Whipple Park August 13, 2025 from 6 to 9 P.M. The town is working in conjunction with Go Goshen and Richard Castro of Crossroads Music. Go Goshen will produce all marketing materials and Mr. Castro will contract the evenings entertainment.
