The Regular Meeting of the Lingle Town Council convened at 6:00 PM September 10, 2025 with Mayor Foster leading the Pledge of Allegiance. Upon roll call, the following were present, constituting a quorum:

Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Wilhelm moved to approve the agenda as presented. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the August 20, 2025 regular council meeting. CM Lambert moved to approve the minutes as presented. CM Wilhelm voiced the second and the motion carried unanimously.

BILLS: CM Lambert moved to approve payment of the town bills in the amount of \$155,300.74. CM Wilhelm voiced the second and the motion carried unanimously.

PUBLIC COMMENT: Resident Charles Koozer addressed the council concerning public complaints of the town Maintenance Department. Mr. Koozer spoke in favor of the department namely TS Dailey and his efforts to care for the town. CM Jerome also spoke in favor of TS Dailey on behalf of a resident that needed assistance with medical equipment during the electrical outage. TS Dailey was able to provide an electric generator to keep the equipment functioning.

POLICE ITEMS: PC Andrews reported: She is dealing with juvenile issues that will include community service. She is also dealing with traffic, suspicious people and incidents.

LEGAL ITEMS: TA Barnes reported: TA Barnes reported information on the Chugwater Wind Energy Project. She has had conversations with various county officials. A county wide MoU for impact funds is being considered for the project. She will report back to the council as information is gathered.

MAINTENANCE ITEMS: TS Dailey reported: Three speed trailers are on order and are funded by a Go Goshen Infrastructure fund grant; A grant is being worked on for radios for the police and fire departments to be submitted to homeland security; Weed maintenance is ongoing throughout the town; An arborist has been contacted and will examine the trees in the cemetery; Bids are out for a building to be built at the transfer station; The pool and restrooms have been winterized for the season.

LVFD ITEMS: FC Bangerter reported: Five ambulance calls and 1 fire call last month; He plans on attending the commissioners meeting on September 16 on the Chugwater Wind Energy Project; An FCC license renewal will be completed as will an ISO report.

ADMINISTRATIVE ITEMS: C/T Reyes reported: The town has been signed up and approved as a LIEAP provider for the 2026 Fiscal Year; C/T Reyes will be attending the WAM Region 1 meeting in Cheyenne on September 18.

NEW BUSINESS: CM Wilhelm moved to approve support of the Goshen County Veteran's Banner Program in the amount of \$250. CM Lambert voiced the second and the motion passed unanimously.

With no further business to conduct Mayor Foster adjourned the meeting at 6:24 PM.
