Mayor Foster welcomed all in attendance and thanked them for being present. Mayor Foster called for approval of the agenda. CM Lambert moved to approve the agenda with the addition of Cheryl Trimble to Public Comment. CM Jerome voiced the second and the motion carried unanimously. Mayor Foster called for approval of the minutes of the September 10, 2025 regular council meeting. CM Jerome moved to approve the minutes as presented. CM Lambert voiced the second and the motion carried unanimously.

PUBLIC COMMENT: Resident Cheryl Trimble addressed the council and thanked the town employees for assisting with an adult employment field trip. She mentioned that the employees, D/C/T Garner and T/S Dailey, did a great job explaining their duties and what the qualifications are for their positions.

POLICE ITEMS: PC Andrews reported: A juvenile was given eight hours of community service and T/S Dailey assisted with the fulfilment of the task; A second juvenile will also be given eight hours of community service and CM Lambert will assist with the completion of the service; PC Andrews has received a new body camera and is in the process of setting it up; She has also been dealing with a dog that keeps getting loose, cat complaints, and traffic.

MAINTENANCE ITEMS: TS Dailey reported: An arborist examined the trees at the cemetery and there is evidence of borers and fungus. A tree will be cut down to be tested; TS Dailey communicated to the council and all town residents that yard waste is to only be placed in the green waste dumpsters and that leaves are not to be placed in trash bags; A grant has been submitted to Homeland Security for Fire Department and Police Department radios; The street sweeper is currently down; The hay field on Freimuth is in the process of being developed and this will be an ongoing project.

LVFD ITEMS: TS Dailey reported: Fire Day will take place October 8, 2025 and the haunted house will take place at the end of October.

ADMINISTRATIVE ITEMS: C/T Reyes reported: He attended the Chugwater Wind Energy Project meeting hosted by the Goshen County Commissioners September 16, 2025. NextEra Energy is setting aside \$12.3 million for impact to Platte, Laramie and Goshen Counties. An MoU between the three counties is being researched and TA Barnes has signed a Letter of Intent on behalf of the Town of Lingle to be part of the Goshen County application process for the Industrial Siting Council for this project; C/T Reyes attended the WAM fall meeting in Cheyenne on September 18, 2025. One topic that was discussed concerned the Direct Distribution received by Wyoming municipalities. Appropriations is considering discontinuing Direct Distribution and replacing it with Sales and Use
