

ORDINANCE NO. 374

AN ORDINANCE AMDENDING SECTION 10. TERMS OF FRANCHISE OF ORDINANCE NO. 358 RENEWING A NON-EXCLUSIVE FRANCHISE TO ***TDS COLLECTION SERVICE INC.***, A WYOMING CORPORATION, TO OPERATE A TRASH AND GARBAGE COLLECTION SYSTEM IN THE TOWN OF LINGLE, WYOMING: DEFINING TERMS: SETTING FORTH THE TERMS AND CONDITIONS OF THE GRANT; PROVIDING FOR COMPANY RULES, RATES, FRANCHISE FEES; TERMINATION AND PENALTIES FOR VIOLATION.

Be it ordained by the Town Council of the Town of Lingle, Wyoming:

Section 10. TERMS OF FRANCHISE: Shall now read:

Section 10. TERMS OF FRANCHISE: The franchise and rights herein granted shall take effect and be in force from and after the final passage, approval and publication hereof as required by law and upon filing of acceptance by Contractor with Town Clerk and shall continue in force and effect for a term of one (1) year, the one (1) year term shall commence July 1, 2025 and conclude June 30, 2026, after the date of filing such acceptance. If the acceptance is not filed within thirty (30) days from the date hereof and placement of containers and system operation herein described begun within thirty (30) days from date hereof, the provisions of this franchise shall be null and void.

All other terms and conditions of current Ordinance No. 358 / Sanitation Services Agreement will remain in effect during the extended period of Ordinance No. 358 / Sanitation Service Agreement.
