If the acceptance is not filed within thirty (30) days from the date hereof and placement of containers and system operation herein described begun within thirty (30) days from date hereof, the provisions of this franchise shall be null and void.

All other terms and conditions of current Ordinance No. 358 / Sanitation Services Agreement will remain in effect during the extended period of Ordinance No. 358 / Sanitation Service Agreement.
